# **Course Description**

This program aims to help mental and medical health professionals working with college-aged students expand their knowledge about early signs of psychosis and recommended assessment and intervention strategies. The ultimate goal is to create opportunities in which young people experiencing the early signs of major mental illness can safely share what they are experiencing and be guided to appropriate resources.

Through a mix of teaching, first-hand accounts, discussion, and skills practice, participants will gain comfort asking about signs of risk, speaking to youth and families about risk, implementing intervention strategies to target early psychosis symptoms, and referring to local specialized services. The program will highlight strategies and guidelines for effectively managing tricky conversations, cultural factors, denial, and safety concerns.
